I HEREBY CERTIFY, I am at least 18 years of age and in good mental and physical health. If I am under 18 years of age, I have a Parents or Guardians written approval to participate in the game.

IN RETURN FOR THE USE OF THE FACILITIES AND/OR ANY OTHER CONSIDERATION, I STATE THAT:

(A) I am aware that Rocky Meadows Paintball Game (Hereinafter referred to as RMP) is a physically and mentally strenuous game involving risk of injury from equipment, other players and the playing environment. I acknowledge that it is the intent of other players in RMP to assault me during the game and that in order to do so, other players will try to overcome any resistance that I may exert by the use of force including the use of an air gun, referred to below, which is powered by CO2 which can exert a pressure of up to 800 pounds per square inch and has a range in excess of 100 feet. The pellets projected from such airguns measure 0.68” in diameter and are made of bio-degradable Shell and Dye. I acknowledge that my physical and mental state are sufficient to enable me to participate faithfully in the “GAME” .

(B) I hereby undertake and assume total responsibility for any risk or injury associated with playing or participating in Rocky Meadows Paintball.

(C) I hereby undertake to play RMP only in accordance with the safety instructions, rules and guidelines which I hereby acknowledge as having heard and understood. I agree never to take any steps or to do any actions which will be dangerous to myself or any other person.

(D) I am aware that RMP does not warrant the condition or safety of equipment, facilities or premises connected with Rocky Meadows Paintball.

(E) I understand and acknowledge that RMP, their respective officers, agents, employees and associated personnel are NOT insured for any liability that may attach to them by my having agreed to participate in the RMP game

(F) I hereby for myself, heirs, executors, administrators, successors and assignees indemnify and save harmless and keep indemnified RMP, their equipment manufacturers, suppliers as well as the staff, agents, representatives, employees, promoters, officers, directors, shareholders, guests, invitees, mandatories and assignees of the aforementioned from and against any and all actions, claims, cost, expenses or demands including legal fees, in respect of the death, injury, loss or damage to the person or property of myself or any other participant or guest, however caused, arising out of or in connection with my playing and attending on the premises in which the offered air gun game, RMP, is played and notwithstanding that the same may have been contributed to or occasioned by the negligence of said parties, their respective staff, instructors, servants, officials, representatives, agents, officers, participants, directors, shareholders, promoters, mandatories, guests, assignees, other players and which negligence may relate, with out limiting the generality of the foregoing to the manufacturer, selection, delivery, possession, use and operation of equipment and supplies and the selection and maintenance of the premises and the natural environment and the conduct and supervision of the airgun game.

(G) I expressly agree that the foregoing Waiver is intended to be as broad and inclusive as is permitted by the law of the Province of Alberta in which the airgun game is conducted and that if any portion therefore is held invalid, it is agreed that the balance shall nevertheless, continue in full legal force and effect.

(H) I hereby certify that I have read & understood this Waiver in its entirety and I have executed same of my own free will without incurring any duress whatsoever. I also acknowledge that I have the right to withdraw from the said game at any time.

(I) I consent to the free use of my photograph or any other recorded sound or image reproduction for future promotional material in such form and at such time as RMP may in their sole discretion determine and I hereby waive any claim for compensation in respect of such use.

(J) I further declare that this document has been drawn up in the English language at my request.

(K) I accept full responsibility for the return or replacement value of the following equipment upon termination of the RMP game. Clothing-\$65.00 ; Safety Mask-\$50.00; Airgun-\$275.00; Barrel Plug-\$5.00; Pods-\$6.00 ; Belts-\$32.00

(L) I have read and understood fully this agreement and recognize it is legally binding.

PARTIAL LIST OF RULES

I am aware of & understand and agree to be bound by the following rules, conditions and understanding, and any other rules which may be explained to me verbally or in writing by RMP and to obey all instructions of RMP.

- (a) I acknowledge and am aware that I must wear my safety mask over my eyes at all times during the game operations and failure to do so may result in injury to my eyes.
- (b) To always wear protective eyewear when using or around persons using airguns and never to point an airgun at any person not wearing protective eyewear and to never remove the protective eyewear when playing in the game field and/or at any time. I acknowledge that no area of RMP facility is totally safe.
- (c) To use equipment only as and when instructed and always to obey game rules and regulations and never point or fire an airgun at any person not participating in the RMP game or at any vehicle, wildlife or domestic stock.
- (d) Never use any projectile other than that supplied by RMP for use with the airgun and to purchase all pellets from RMP.
- (e) Not to participate in RMP game or use equipment while under the use of alcohol or drugs.
- (f) Not to carry or use any weapon, dangerous substance or devise and to use only the airgun supplied or approved by RMP
- (g) That the game operators(s), their agents, instructors, and personnel shall have the right at any time, which they may exercise in their sole discretion, to cancel my participation in the airgun game offered, for any reason and without giving cause.
- (h) To take care of the airgun in my possession and should I lose it, or return it to RMP in a condition other than reasonable wear & tear at RMP opinion, I hereby agree to pay for the loss or damage to the said airgun. I also agree to pay for any other damage to the facilities by my actions.
- (i) I also acknowledge and understand that I have the right to ask questions at any time with the view of understanding the complete game procedure and operations in its entirety and after the game brief.
